Brain scans: Two ADHD medications can be better than one. When 208 kids and teens, ages 7 to 14, received the ADHD medications guanfacine (Intuniv, Tenex) 3 or d-methylphenidate (Ritalin, Concerta and other brand names) 4 or both drugs for eight weeks, researchers from the University of California Los Angeles found that those taking the combination got the biggest improvements in attention.
